These regulations are not met as evidenced by the following:
Based on record verification, review of progress notes, review of policy and procedure and interviews the facility neglected to implement their written policies and procedures prohibiting neglect by failing to:
1) Ensure that 1 of 1 client (R1) was bathed in appropriate water temperature. R1 sustained deep partial thickness burns described as total body surface area burns to 30% of his body. On 12/28/05, R1 underwent surgery for debridement and skin graft,
2) Ensure that staff reported to Administration their observation that the water was hotter than usual after the mixing valve had been cleaned by the maintenance personnel on $12/1/7/05$.
3) Ensure that staff implemented the policy on Direct Support Personnel (DSP) Monitoring of Hot Water Temperatures and
4) Ensure that administration monitored staff implementation of their policy and procedure on Monitoring Hot Water Temperatures.
Findings include:
 Per resident profile R1 is 54 year old male whose diagnoses includes Profound Mental Retardation, Seizure Disorder and Cranio-facial Anomaly. Z2, was interviewed via phone on 12/28/05 at 9:08am. Z2 stated, "R1 sustained 30% total body surface area burns." Z2 further added, "R1 has deep partial full thickness burns." Z2 was asked what could have possibly caused the burn, Z2 answered, "Plausible mechanism is most likely hot water due to the pattern of the burn. R1 had burns to his bilateral lower extremity and right upper extremity." Z2 added, "Today R1 is in surgery for debridement and skin graft. Tomorrow, we will be putting a peg tube in him because we need to give him nutrition, high in protein." Surveyor then asked Z2 for R1's prognosis, Z2 stated, "R1 should be back to baseline hopefully after all the treatments."

350.3240 a) E11, DSP was interviewed via phone on 12/28/05 at 12:32pm. E11 stated, "I came in at (Cont'd.) 11:00pm. E4 told me that R1 was acting funny and didn't eat his food. E4 then showed me the front of his right foot/ankle. I saw a busted blister, kind of big almost about 2" in diameter. R1 was laying on his right side. I was thinking somebody burned him but I didn't think about it again because I felt that nobody will burn him. E4 said it looked like somebody burned him. E4 then told me to not take him to the bathroom because he wasn't acting right. Every time I took R3 (R1's roommate) to the bathroom, I checked on R1. R1 always sleeps in a fetal position on his right side so I didn't see his right arm. At 5:00am, I told R1 to grab on to my arm, then I saw his right arm, it was burnt. I ran and called E13, DSP. I then removed R1's clothes and saw the burns. His testicles, his ankles, his heels they were burnt."Surveyor asked E11 if R1 takes a shower or a bath, E11 stated, "R1 takes a shower. I've never seen anybody give R1 a bath." E11 added, " I don't think R1 can get himself in and out of the tub. Staff have to lift R1 up to get him into and out of the tub." Surveyor asked E11 what was R1 wearing, E11 stated, "R1 was wearing a short sleeve T-shirt." E11 added, "R1 sits with his arms always folded up, so it is hard to see it (burn on his right arm)." E11 was asked if she checks the water temperature prior to giving clients baths, E11 answered, "I usually check the water temperature with my wrist."

E3, DSP was interviewed on 12/27/05 at 3:35pm. E3 stated, "On 12/22/05 R1 was sitting in the living room for 8pm medications and after medications he was taken by E4 to his room." E3 added, "R1 was already wearing his pajamas when he took his medications, he already had his bath." Surveyor asked E3 what R1 was wearing, E3 stated, "I believe he had a T-shirt on with dark jogging pants and socks on." When asked if she noticed anything on R1, E3 answered, "No, I didn't notice anything on him, I didn't notice his arms just that he had a T-shirt on." E3 added, "When I gave R1 his medications he was sitting down and he looked tired and not well." Surveyor asked E3 if she had any problems with the water being hotter than usual, E3 stated, "For a couple of days the water was very hot but I always made sure the water the residents get into is lukewarm." Surveyor asked what the water temperature was, E3 answered, "The temperature was over 110 degrees (F), after I read over 110 degrees (F), I regulated the water until it read less than 110 degrees (F) per policy."

E6, DSP was interviewed on 12/27/05 at 3:15pm. E6 stated, "On 12/22/05 R1 didn't show any signs of pain, he just looked like he was coming down with a cold because he didn't eat dinner." Surveyor asked E6 if she checked the water temperature prior to giving clients a bath or a shower. E6 stated, "I used my hand every time I give someone their bath, if it's too hot for me, I know it's too hot for them even though I like hot showers." When asked if she had problem with the water being hotter than usual, E6 answered, "Monday (12/19/05) when they fixed it, it was hotter than normal. Tuesday (12/20/05),

Wednesday (12/21/05)and Thursday (12/22/05) it was the same as Monday, the water temperature is supposed to be 110 degrees F but I'm sure it was over it." Surveyor asked if she ever used a thermometer to check the water temperature, E6 stated, "I looked at the thermometer but neglected to use it." Surveyor then asked if E6 reported the water temperature to anybody, E6 stated, "No, I didn't report it to anybody."

E5, the cook was interviewed on 12/27/05 at 3:02pm. E5 stated, "On 12/22/05 (Thursday) R1 was here for dinner , he ate very little. He looked like he was coming down with a cold, other than that he seemed fine." E5 was asked if she had any problems with the water being hotter than usual, E5 stated, "I don't have any issue with the water being hotter than usual that I can remember."

Z4 was interviewed via phone on 1/10/06 at 10:25am. Z4 stated, "R1 was fine. He wasn't sick that day (12/22/05). R1 ate all his lunch and he ate all his snack. He came in nice and happy, he was smiling and was in a great mood." Surveyor asked if Z4 toileted R1 on 12/22/05, Z4 stated, "When I toileted him, he had on a yellow and green patterned boxer shorts (mostly green) and he was fine, nothing unusual that I observed."

E2, was interviewed on 12/27/05 at 11:50am. E2 stated, "E4 had told me that R1 had scratched his foot and there was a section in his foot that he scratched it raw. E4 stated R1 wasn't feeling well and said R1 appeared to be coming down with a cold. E4 told me a little bit after 11:00pm. I told E4 to do first aid , bandage it up and call the nurse and tell the night staff to monitor him every 15 minutes." E2 continued, "E4 never paged the nurse."

Record verification showed no documentation of any assessment on R1 performed by any of the staff on 12/22/05 when he was noted to be not feeling well and "might be coming down with something".

On 12/23/05 at approximately 1:30pm surveyor checked the water temperature in the furnace room. It read 106 degrees F and the water heater had been turned off. E2, Assistant Administrator was interviewed at 2:00pm. E2 stated, "I got here at 7:00am (12/23/05) and the water temperature was 132 degrees F." E2 added, "The water heaters were turned off after 8:30am after the Chief of Detectives was here." Surveyor asked what the facility policy was with regards to bathing the clients, E2 answered, "Staff should have checked the water temperature before every bath, if it is below a 100 degrees F or over 110 degrees F they (staff) can't give a bath." E2 added, "Staff does not need to log it (water temperature), our maintenance personnel check it quarterly." E2 then added, "The mixing valve was just serviced 12/17/05 and the water temperature after it was done was 106 degrees F." E2 then stated, "The knobs of the water heater were tampered with, the setting was set all the way to hot."

350.3240 a) The facility's hot water heaters remained turned off until 12/28/05 at approximately 11:00am (Cont'd.) after Z1 had checked the system. Z1 was interviewed via phone on 12/28/05 at 11:28am. Z1 stated, "The water heaters are fine. The mixing valve is running fine; the maintenance personnel had cleaned it again Friday 12/23/05. If something got stuck then it must have been released." Z1 added, "If the water temperature in the water heater is turned all the way hot, and you have a working mixing valve it should still be okay. Sometimes your gates/ spring in the mixing valve gets stuck. If stuck on cold, only hot water flows through and water would be hot and if stuck on hot, only cold water flows through and your water would be cold."

E9,a Maintenance Personnel was interviewed on 12/27/05 at 12:07pm. E9 stated " On 12/22/05 in the afternoon, when I walked in the furnace room to pull the door to the crawl space, E4 walked into the furnace room before me and turned the mixing valve all the way to cold, then he left the furnace room." E9 added, "The mixing valve usually is in the center." Surveyor asked if they changed the mixing valve back to it's original setting, E9 stated "No."

E10, a Maintenance Personnel was also interviewed on 12/27/05 at 11:50am. E10 stated, "After working on the crawl space(on 12/22/05) I washed my hands and the water didn't feel hot." E10 added, "You can regulate it (the water) at the shower with the cold water tap on."

R5 was interviewed on 12/27/05 at 10:21am. R5 stated, "I remembered seeing E4 going into the furnace room while the maintenance guy was working in there." R5 was asked who gave him a bath on 12/22/05, R5 stated, "E4 gave me a bath that night after 8pm, the water was kind of hot but not very hot." Surveyor then asked R5 if he saw E4 checking the water temperature, R5 stated, "No, he (E4) didn't check the water temperature."R5 added, "He did check the water temperature some other times." R5 was asked how staff treat him and the other clients, R5 answered, "Staff treat me fine. E4 is always nice but that Thursday (12/22/05), he was always on the phone, somebody was always calling him."

R3 was interviewed on 1/10/06 at 3:25pm. R3 stated, "R1 is in the hospital because he got hurt." When asked why R1 got hurt, "R3 stated, "He fell down."Surveyor then asked R3 if the water is hot, R3 answered, "Yeah."

The facility's DSP Monitoring of Hot Water Temperatures Policy was reviewed. The policy's procedures includes the following:

- 1. Water temperature will be monitored prior to bathing any individual deemed incapable of regulating water temperatures as determined by the Water Regulation Assessment.
- 2. DSP will check the water temperature using the following procedure:

A. Run the water for no less than three minutes

B. Place a cup under hot running water

C. Put the thermometer into the cup and test the temperature for 30 to 60 seconds.

3. If the water temperature exceeds 110 degrees, immediately implement the following procedures to ensure the safety of the individuals, suspend use of hot water until steps A-F are completed.

A. Calibrate the thermometer by completely filling a glass with ice and adding enough water to cover the ice. Insert the probe and let sit until temperature stabilizes. Read the thermometer. If it is not reading 32 degrees F adjust the thermometer according to directions until it reads 32 degrees F.

B. Re-test hot water temperature. If it remains above 110 degrees proceed to 3C.

C. Shut off hot water at the main hot water shut off.

D. Document the water temperature on a GA-26 for a review by management and

E. Contact the personnel listed on the emergency contact phone list.

F. Contact the maintenance staff to examine the system.

G. After system malfunctions and prior to resident use of hot water, staff will be in serviced using the approved GA-9 for hot water system failure.

E8 was interviewed on 12/27/05 at 1:55pm. E8 stated, "I worked the first shift and I usually give baths during the weekends." Surveyor asked if E8 checks the water temperatures prior to giving clients their baths, E8 answered, "Yes, usually with my hand. We had a thermometer but I didn't use it. "

E12 was interviewed via phone on 1/10/06 at 9:38am. E12 stated, "Yes, I do check the temperature with my hand before, we had a thermometer but it broke and recently (after the incident of 12/22/05) we've gotten a new thermometer and I've been checking the water with the thermometer."

Z3 was interviewed on 12/27/05. Z3 stated, "Nobody among the staff I interviewed stated that they checked the water temperature with a thermometer prior to bathing a client."
