This REGULATION is not met as evidenced by:

Based on observation and interview, the facility has failed to correct violations found on 4/1/09 in order to ensure that food is prepared and stored in a sanitary manner.

Findings include:

Floor tiles were broken and missing throughout the dietary department rendering them difficult to clean. Floors throughout the dietary department had a build-up of soil and debris at the floor/wall junctures, and behind equipment. (Illinois Food Service Sanitation Code 750.1200a)

The shelving in the dry storage area is constructed of wood which is chipped, porous, and non-cleanable. (Illinois Food Service Sanitation Code 750 Section 750.650a)
