Keynote Presentation



Kim Y. Smith, M.D., M.P.H., is an associate professor of medicine in the Section of Infectious Diseases at Rush University Medical Center in Chicago. She also serves as an attending physician at Stroger (formerly Cook County) Hospital and the CORE Center in Chicago. Dr. Smith received her M.D. and M.P.H. degrees from the University of Michigan in Ann Arbor. Dr. Smith's major areas of interest include issues related to African Americans and women with HIV disease and HIV prevention in the African-American community. Dr. Smith is an active investigator and chair of several studies in the AIDS Clinical Trials Group (ACTG) of the National Institute of Health (NIH) and was awarded the John T. Carey Young Investigator Award of the ACTG in 2002. She currently serves as the chair of the Underrepresented Populations Committee of the ACTG. She has published more than 50 abstracts, and manuscripts. In 2009 she was co-editor of the first of its kind textbook on HIV/AIDS in communities of color and she is currently co-editor of the online HIV textbook [In-Practice](#). In addition, Dr. Smith has served as an HIV/AIDS medical expert in many appearances with Magic Johnson and on the "Oprah Winfrey Show." She was awarded the "Heroes in the Struggle Award" by the Black AIDS Institute in 2009.

Plenary Sessions



Gustavo Aquino, M.P.H., is the associate director for program integration of the National Center for HIV/AIDS, Viral Hepatitis, STD, and TB Prevention (NCHHSTP). Aquino began in his current role in October 2008. He previously served NCHHSTP as a team leader in the Prevention Program Branch of the Division of HIV/AIDS Prevention. Aquino also played a key role in bringing life-saving drugs to persons impacted by the TB epidemic in Russia while he served as the in-country Public Health Advisor for the Division of TB Elimination in Moscow, Russia, implementing demonstration projects in collaboration with national and international partners. His public health work is founded on experiences gained working in state and local programs, conducting sexually transmitted disease prevention work in Florida and Chicago, and TB control and prevention work in New York City, New Jersey, and Puerto Rico. He joined CDC in 1990, and is a graduate of the University of Puerto Rico, where he received a Masters in Public Health.



Brian Bongner is the program manager for the Lake County Health Department and Community Health Center's STI Program where he directs the day-to-day operations of the County's HIV/STI/Viral Hepatitis prevention and care programs including the development, implementation and evaluation of all program activities and projects. Bongner began his career in 1993 at Saint Louis Effort for AIDS as their first Treatment Education Program Manager and has since worked with numerous governmental bodies to promote treatment education, health literacy, medical management, capacity building and advocacy. His public health career is founded on his successful work with Title I / Part A planning bodies; Title II / Part B consortia; local, state and federal prevention / care teams; and, most recently through his commitment in Illinois for the partnerships between care and prevention; STI, HIV and HCV; community-based programming and state partners; and federally qualified health centers and local health departments.



Julie Pryde, M.S.W, L.S.W., CPHA is the administrator of the Champaign-Urbana Public Health District (CUPHD). Prior to this position Pryde was the Director of CUPHD's Division of Infectious Disease Prevention and Management. Pryde is an accomplished grant writer, researcher, and speaker. She has been published in several professional journals and has presented at many national conferences. She has also been a consultant and speaker with the Illinois Department of Public Health. Pryde has received awards from the Illinois Department of Public Health, the Illinois Public Health Association, the Greater Community AIDS Project, and the University of Illinois.

Plenary Sessions *(continued)*



Chyvette T. Williams, Ph.D., is an assistant professor of epidemiology and biostatistics, a senior research scientist of community outreach intervention projects, and program faculty for the AIDS International Training and Research Program at the School of Public Health, University of Illinois at Chicago. Williams has conducted research in Baltimore, Philadelphia and Chicago, which focuses on understanding social and contextual factors that increase the likelihood of HIV risk behaviors and other antisocial behaviors such as violence and illicit drug involvement among marginalized populations in urban areas. She has worked on several federally-funded HIV projects, both research and service-oriented. Williams is also the local evaluator for the Health Resources and Services Administration-funded Enhancing Linkages to HIV Primary Care and Services in Jail Settings Initiative and is a co-investigator on the Seek, Test and Treat study for criminal justice populations in Illinois. She is the principal investigator of a National Institute on Drug Abuse-funded study examining drug and sexual behaviors among young adults in a high-risk area and testing the feasibility of using respondent-driven sampling to recruit a community sex network. She is a member of the Chicago HIV Prevention Planning Group, the advisory group working closely with the Chicago Department of Public Health to develop HIV prevention plans for the city of Chicago.



Bradley P. Stoner, M.D., Ph.D., is an associate professor of anthropology and medicine at Washington University School of Medicine, St. Louis, Mo, where he specializes in clinical epidemiology, diagnosis and treatment of sexually transmitted diseases (STDs). Stoner serves as medical director of the Centers for Disease Control-funded St. Louis STD/HIV Prevention Training Center, and from 1995-2006 served as chief of STD services for the St. Louis County Department of Health. Stoner studied anthropology at Harvard and McGill universities before completing the M.D./Ph.D. program at Indiana University. Following internal medicine residency training at Duke University Medical Center, he undertook infectious disease fellowship training at the University of Washington in Seattle, where he studied and conducted research on the clinical epidemiology of STDs. He is board-certified in internal medicine and infectious diseases.



Charlie Rabins, M.P.H., is currently a senior policy and data analyst with Health Care Education and Training, Inc. in Indianapolis Indiana. Rabins has worked on STD prevention and containment for more than 38 years at the local, state and federal levels. He was Chief of the Illinois Department of Public Health's (IDPH) Sexually Transmitted Disease Section from 1989 through 2010 and principal investigator on the IDPH's Adult Viral Hepatitis Prevention Coordinator grant from the Center for Disease Control and Prevention (CDC) from 2007 through 2010. Rabins also served as acting chief of the Department's HIV/AIDS Section from 2000-2003. He was involved in the Illinois HIV Prevention Community Planning Group and the Region V Infertility Prevention Project (RVIPP) Steering Committee since their inception. At the national level, he served as chair of the National Coalition of STD Directors (NCSO) from May 1998 to February 2000 and was a member of its executive committee from 1996 to 2007 and again in 2010. He received the IDPH Outstanding Leadership Award in 1996, the Illinois Public Health Association's Distinguished Service Award in 1997, a 2001 Leadership and Vision Award from the AIDS Foundation of Chicago and the Jack N. Spencer Award from the Centers for Disease Control and Prevention in 2010 for a career of exceptional contributions to excellence in STD prevention. Rabins was a fellow of the Midwest Public Health Leadership Institute and also served as a faculty member for the CDC National STD Program Managers Training Course from 2009 to present.



Jeremy D. Young, M.D., M.P.H., was trained in internal medicine and infectious diseases at the Ohio State University Medical Center. During fellowship, he also received a Master of Public Health (MPH) degree. During his time at Ohio State, he was not only trained in the clinical management of HIV infection, but how to provide care via telemedicine technology. In 2009, he was recruited to the University of Illinois at Chicago with the goal of establishing an HIV Prison Telemedicine program. This program began providing patient care for all offenders in the Illinois Department of Corrections (IDOC) system in July, 2010. Since that time, the educational and research initiatives have expanded significantly within the program, including an NIH R01 grant for a specific 5-year project.
