#### Call to Order:

The meeting was called to order at 10:05 am

The minutes of the September 21, 2012 meeting were reviewed and approved.

### **Emergency Call Center Report:**

- 1) Dr. Wahl summarized the quarter report that was sent for review to each committee member for the time period of July September 2012.
- 2) There was a review of dropping call volume, especially in the pediatric population with a discussion on:
  - a. Declining birthrate
  - b. Changes in accessing data: smart phones and internet being potentially disruptive technology
- 3) Review continued increase in calls from healthcare facilities.

Dr. Ortinau stated it would be helpful for the board to get a better understanding of the measurements of acuity of calls (disposition) and time on phone and/or EMR system if available. It was agreed that this would be a focus of the next board meeting.

- 4) Dr. DesLauriers presented the call center metrics over time at the poison center including increasing wait time and call abandonment.
  - a. Reasons for decreasing call center metrics discussed regarding budget and staffing.

#### Outreach:

 Vickie Dance gave a brief overview of the current outreach efforts and a review of the "My Child Ate" web-based information series highlighting typically non-toxic pediatric exposures for parents who desire trusted information over the internet as opposed to calling a 1-800 number. "Meet them where they are at" was the focus.

### Historical Budget vs. 2013 budget:

A review of the 2009-2011 actual budgets, forecasted 2012 budget and 2013 projected budget was presented

A comparison of national average revenue vs. IPC revenue was presented showing the IPC has ¾ of the per capita revenue of the national average.

# Other Business:

All IDPH committees and boards must have by-laws in place. It was agreed that Jack Fleeharty would provide templates for the IPC. Dr. Wahl would provide a draft for Dr. Aks. Once reviewed it would be presented to the committee for discussion.
