DeWitt explained the purpose and need for bylaws which the Department expected to have drafted and ready for review and approval by the next meeting.

Culp thanked everyone for attending the last meeting and for providing feedback at the plumbing exams he attended.

DeWitt presented the group with the new law for expedited licensing for military members and their spouses effective January 1, 2013. The new law requires licensing agencies to act quickly on any application from an applicant that meets the qualifications and issue a temporary license until a final decision is made for final approval of the applicant according to the qualification criteria. The purpose of the law is to facilitate military members starting work as soon as possible when they have to relocate. The Department sought the Board's feedback on implementing a process for determining eligibility and process for issuing a plumbing license. The language requires the Department to approve training and experience that is "substantially equivalent" to its requirements, so a decision will need to be made on whether a license from another state would be sufficient to qualify for admittance to the Illinois plumbing exam or what criteria must be met. The Plumbing Program will draft criteria used to determine 'substantial equivalent' and present to board.
