## **Geothermal Rules Update**

David Johnson, IDPH gave an update on the progress of the Closed Loop Well Contractor's Certification Rules. The rules have returned to the Department for review of the comments resulting from the 45 day first notice comment period. It was explained that the Department would be responsible for responding to all of the comments and resubmission of the rules to JCAR for second notice. The discussion included an 18 month plan to implement the registration process if the rules are promulgated. The registration process was discussed in detail.

## **Election of a New Chairman**

George Gaffke explained that he was ready to ease out of the chairman's position of the Board. Since he is not directly affected by the decisions of the Board, he explained that he may not have a good perspective on the pulse of the industry. George then explained the duties of the chairman. George agreed to remain chairman for one more year.

## **Exam Questions for 2014**

The exam questions for 2014 will be submitted to Elaine by January 15, 2013. Once again the test will remain the same for both April 2014 and October 2014.

## **Other Business**

Setback Distances being set by County Health Departments:

Language in the water well code, such as setbacks in highly permeable soils, was discussed. It was agreed that the next code change process should address these issues to clarify the intent of the code. If a driller has an issue with a local health department the driller should go to the regional level of IDPH with the issue to get it resolved.

Holding up a building permit for a well upgrade:

A Carroll County building inspector is questioning an existing well on the property and asking that it be up to current code before a permit for a house would be issued. It was agreed that the issue was not a water well code issue, but an issue to be remedied by the home owner.

Hydro-fracturing Issues:

The proposed requirement to have a water well driller on site during all hydro-fracturing in the proposed state hydro-fracturing rule was discussed. It was suggested that IDPH keep an eye on the regulations to raise awareness of the effect that the rule may have on licensed water well drillers.

Comprehensive Inspections of water well construction:

Reciprocity for local health departments regarding comprehensive well inspections was discussed. As of this meeting there is no reciprocity but the local health protection grant rules are being amended to address comprehensive well inspection requirements.

Work being performed by non-licensed individuals:

The board discussed several cases where individuals were working under another licensed contractor. One case of a person who let his license lapse for more than 3 years was discussed and it was determined that the rules would have to be enforced and the individual would have to retake the exam and pass prior to renewing.
