## Geothermal Rules Update

David Johnson, IDPH gave an update on the progress of the Closed Loop Well Contractor's Certification Rules. The rules were to have gone to JCAR for final vote. The vote on the rules was delayed by the Geothermal Alliance of Illinois. The issue that they had was in the setback distances from sewers to geothermal installations. A compromise between the geothermal industry and the groundwater protection people was reached and drafted in the rules. The final proposal was presented to the Board.

## **New Exam Questions**

The Board members posed the question of since the rules have changed, the exam questions should be reviewed and new questions added. The Board discussed the possibility of coming up with new questions at a January meeting or reviewing the portion of the exam that they are administering during the exam. It was discussed that the technology changes in the pump installation equipment has diversified to the point that questions on each system would not be fair and reasonable. A proposal to have IDPH select questions for the exam and have the Board members review them prior to the exam was discussed. IDPH would present a solution at the next meeting.

All applicants were electronically mailed their test scores in a letter of pass or fail on May 5, 2014. Successful applicants were mailed their licenses. A list of licensees was electronically mailed to the Illinois Association of Groundwater Professionals.

## **New Rule Interpretations**

The Board discussed new rules that were put into the code on November 25, 2014. Specifically, Germantown Well would be unable to use the tiles that they manufactured for bored wells due to the fact that Section 920.90 k) was changed to require all concrete tile to be manufactured with reinforcing mesh. The Board suggested a variance be granted since the tiles had been used for many years without failure. It was suggested that the rule be changed to allow other manufacturing techniques to be approved by the Department with proper engineering proof. The change to Section 920.90 m) that requires all buried slabs used in bored well construction to be approved by the Department was discussed. Since no slabs have ever been approved, it was suggested to have the health departments use comprehensive inspections as educational opportunities and to inform the contractors that approved products had to be used. The same approach was suggested for the new requirements to grout the entire length of the annulus instead of just 60 feet. Permitting of well repair was discussed as part of the definition of modification. The role of a pump installer was then discussed in regard to repairing a casing or extending a casing.

# **Other Business**

Michael Gross announced his retirement from the Board effective after the October 16-17, 2014 meeting and exam.

## Whiteside and Ogle County Permit Fee and Requirements

Whiteside County is charging \$115 for permits. Ogle County has a supplemental permit fee and supplemental well permit form that could delay a permit if not supplied. This requires many facets that are not the responsibility of the well driller. Whiteside is requiring a waiver for less than 200 feet from a potential primary source owned by the same person putting a well in. Clay Simonson is telling all the Rockford Region's local health departments to hold up permits for no pump installer on the permit.

#### Official Retirement of George Gaffke from the Board

George Gaffke presented his letter of resignation from the Board to IDPH effective May 1, 2014.

### Ryan Kerry, Meadow Drilling Presented Symmetrix System

Mr. Kerry presented his history of being allowed to install closed loop wells in Cook County with county inspector Dave Rohback present, using the Symmetrix drill. Mr. Kerry then reported that he drilled a water well in DuPage County and was cited for drilling an upper enlarged hole for a water well less than three inches. Mr. Kerry's argument was that DuPage County allowed Pioneer to drill with the same rig in their county. He also stated that his system is essentially the same as a cable tool.

The Board argued that there is a difference in this method and the cable tool method due to the over drilling of the bore hole. The question was posed as to how the method could be approved. The Board recommended that evidence of the system used in another state that showed a good record exists for the method or proof of the grout sealing the hole. The conclusion of the Board is that there needs to be more documentation to recommend this method for approval.

### Jeff Tyrrell Presented a Case to Revoke a Contractor's License

Mr. Tyrrell stated that he had proof that the experience requirements for Bradley and Guy Stone's water well exam applications were fraudulent. He also stated that Bradley and Guy Stone had cheated on their exams in 1991. The Board stated that it is hard to get a States Attorney to take a case. Dave Johnson recommended that Mr. Tyrrell put together his affidavits and evidence and submit it to the Department for review.

George Gaffke scheduled the next Board meeting for October 16, 2014, to be held at the Ramada Limited North in Springfield, beginning at 4:00 p.m.
