RE: Immunization Recommendations for Individuals Displaced by Hurricane

Katrina

The following information should assist you as you arrange to provide services to individuals that have been displaced by Hurricane Katrina. Local health departments may utilize any available VFC vaccine they have for administration to these individuals as indicated by the most current CDC interim recommendations. Additional vaccine should then be ordered from a vendor for direct shipment to the local health department to replace the inventory. Please keep track of doses of vaccine administered and retain invoices/bills which will be submitted for reimbursement to IEMA through EMAC, Emergency Management Assistance Compact. Additional information on submitting expense related documents will be shared when it becomes available. If you are administering vaccine to VFC eligible children, please continue to follow the VFC guidelines and utilize the inventory you have.

As referenced above, CDC's "Interim Immunization Recommendations for Individuals Displaced by Hurricane Katrina" should be followed when assessing an individual's need for vaccination. In addition, this memorandum includes the "State Vaccine Requirements for School Entrance/Attendance". We have added the existing Illinois school requirements to allow for easier assessment and comparison. The Immunization section is also working with appropriate points of contact with the existing registries in affected sates to gain "read

only" access for student's records. Over the coming weeks, we may have the ability to confirm what immunizations children may have on a case-by-case basis.
